

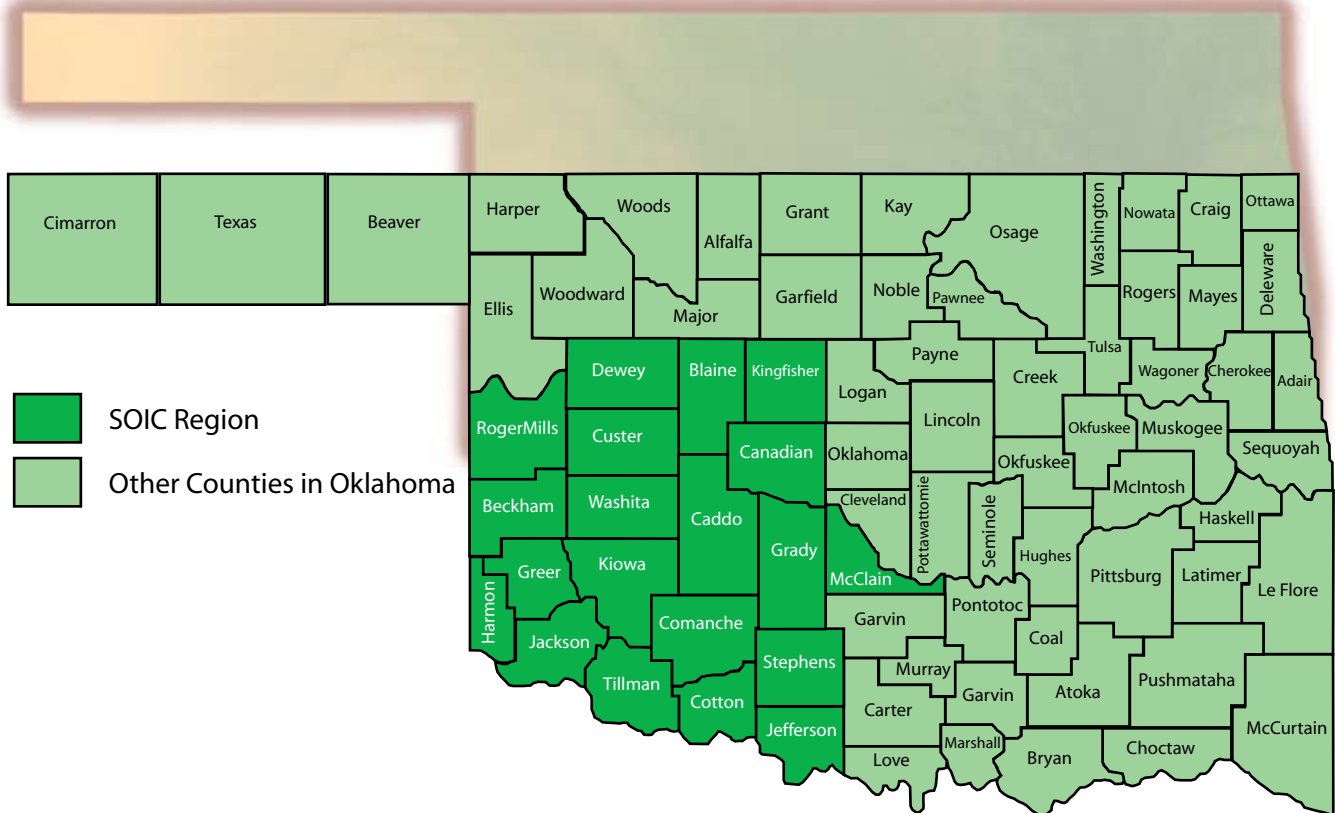
Business Demographic Series: *SOIC Demographic*

This report highlights the demographic profiles of counties included in Southwest Oklahoma Impact Coalition (SOIC). There are four sections in this report, which are comprised of Personal Income, Employment, and Farm Income (Section A); Demographic Characteristic (Section B); Economic Characteristic (Section C); and Social Characteristic (Section D). Data for the first section, Personal Income, Employment, Farm Income, was obtained from the Regional Economic Information System (REIS) 2006 database. Likewise, statistic figures for Demographic Characteristic, Economic Characteristic and Social Characteristic were collected from the U.S. Census Bureau, Census 2000.

The following map provides an excellent view of the alliance between twenty counties that formed the SOIC region, which are Beckham, Blaine, Caddo, Canadian, Comanche, Cotton, Custer, Dewey, Grady, Greer, Harmon, Jackson, Jefferson, Kingfisher, Kiowa, McClain, Roger Mill, Stephens, Tillman, and Washita.



Section A: Personal Income, Employment, and Farm Income

This section contains current information on a wide range of topics including information on Personal Income, Employment, and Farm Income for 2004. Row items also included Derivation of Personal Income and Components of Earnings by work place. Derivation of Personal Income consisted of work place and place of residence, contribution for government social insurance, adjustment for residence, dividends, personal current transfer receipt. Components of Earnings by Work Place comprised of wage and salary disbursements, pension, and proprietor. Information in this section was compiled from the Regional Economic Information System (REIS) 2006 database for counties included in the SOIC region.
