

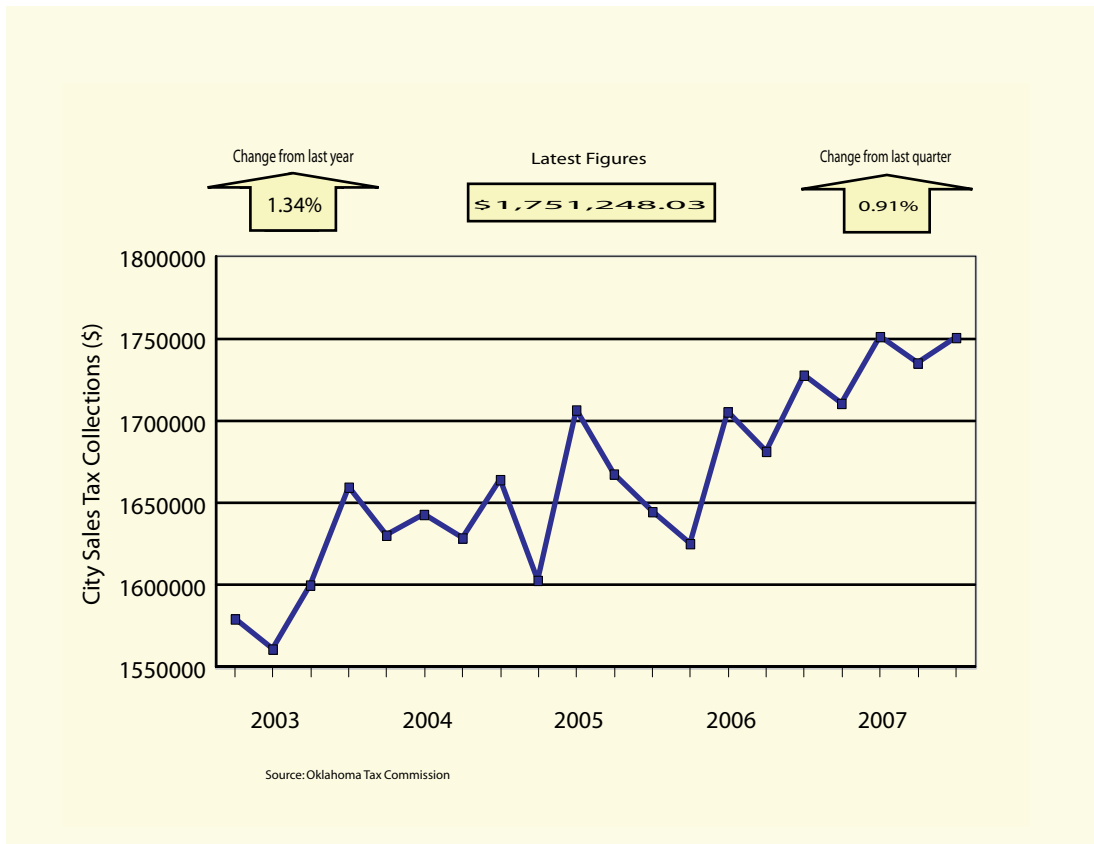
# SOIC Regional Economic Indicators: *City Sales Tax Collection*

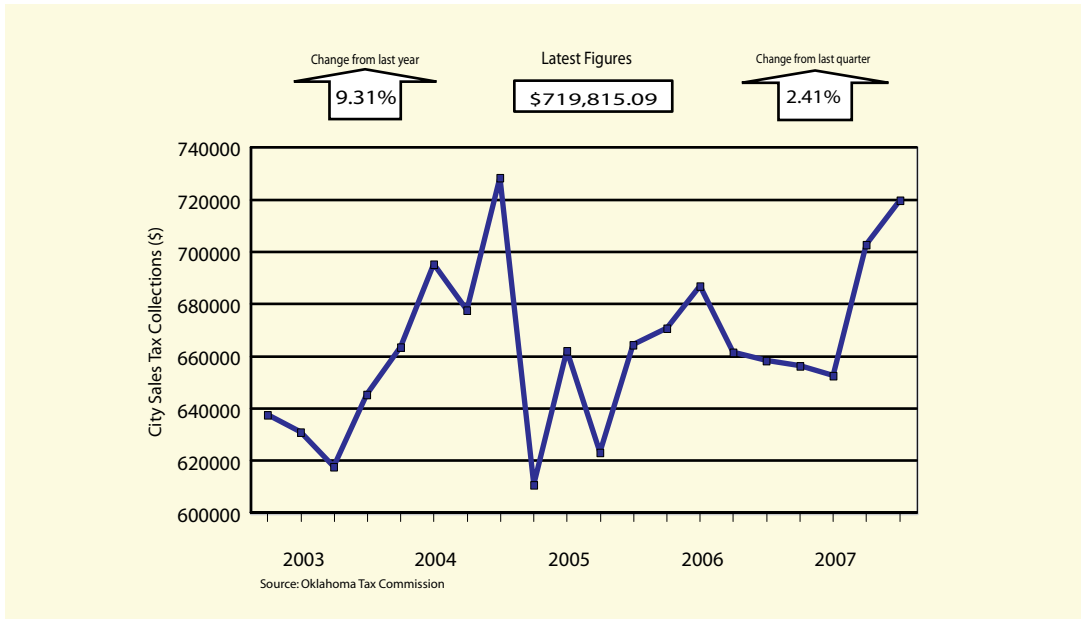
Regional city sales tax collections rose 2.35% (\$0.726 million) in 3rd Qtr 2007 from the previous quarter. During this time period, 20 of the 25 cities increased their city sales tax collections. Over the course of the past year, 19 of the 25 cities managed to grow their city sales tax collections. Of these cities, Sayre managed the greatest percentage gains with 85.98% (\$0.229 million), followed by Burns Flat with 20.40% (\$0.011 million), Kingfisher with 17.75% (\$0.083 million), and Yukon with 10.61% (\$0.334 million). Over the entire time period from 4th Qtr 2002 to 3rd Qtr 2007, regional city sales tax collections stand at a combined \$0.531 billion in the SOIC region.

*Chart 1: Altus City Sales Tax Collection*



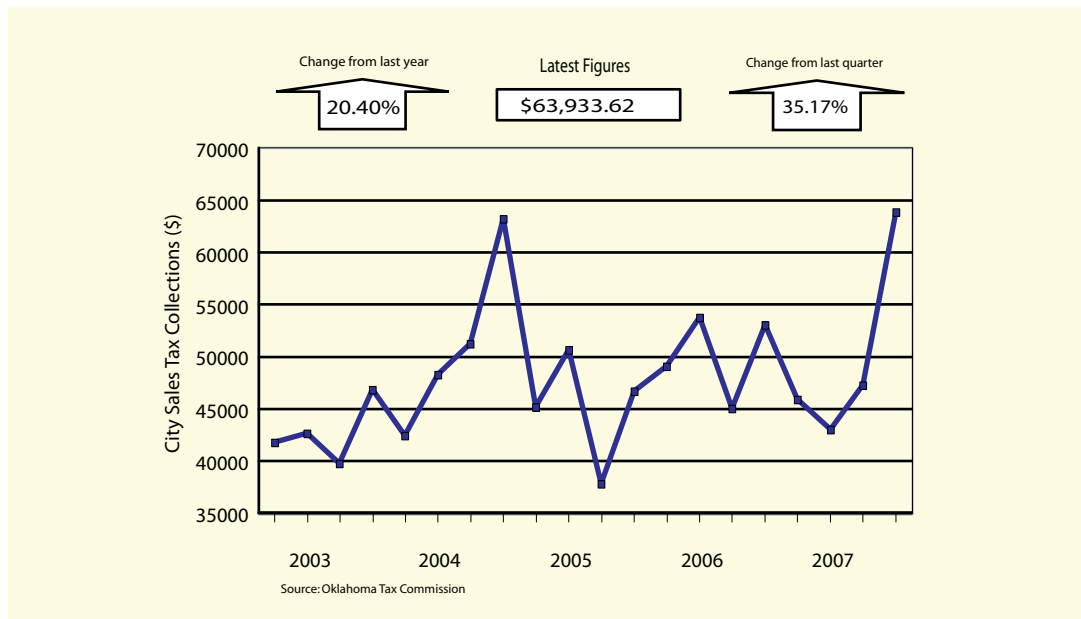
Altus city sales tax collections are up 0.91% on the quarter for a total city sales tax collection of \$1,751,248.03.

**Chart 2: Anadarko City Sales Tax Collection**



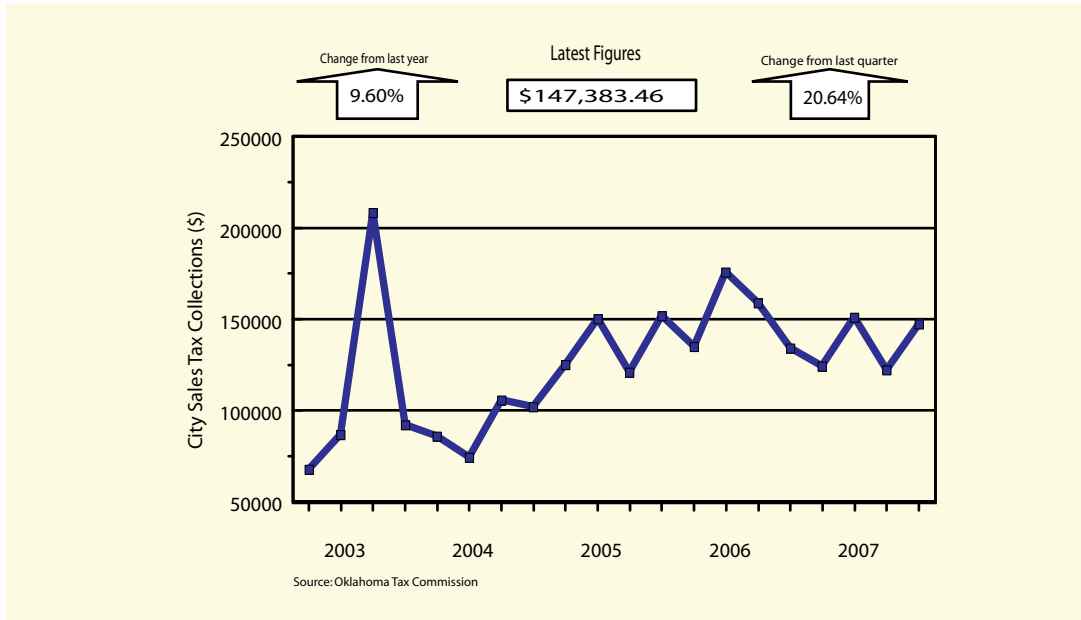
Anadarko city sales tax collections are up 2.41% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 3: Burns Flat City Sales Tax Collection**



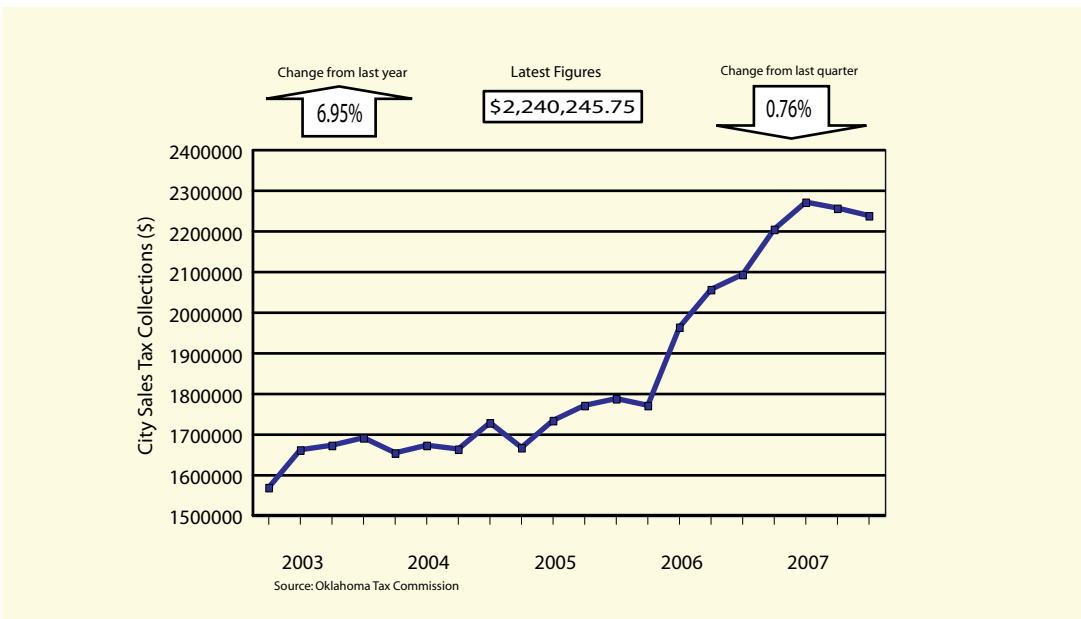
City sales tax collections for Burns Flat rose 35.17% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 4: Cheyenne City Sales Tax Collection**



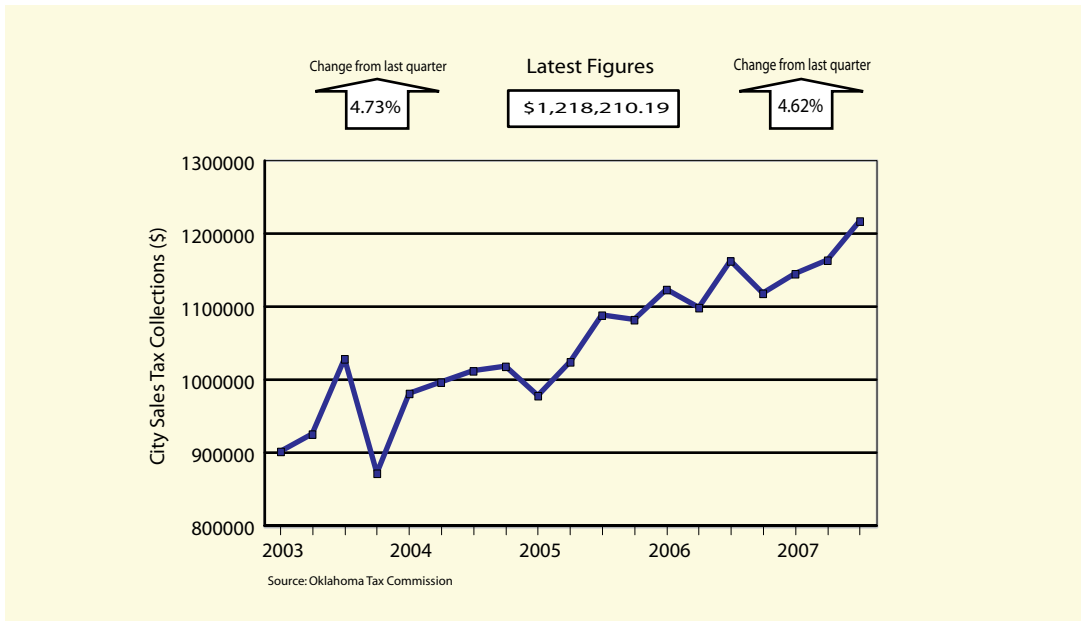
Cheyenne city sales tax collections are up 20.64% on the quarter for a total city sales tax collection of \$147,383.46.

**Chart 5: Chickasha City Sales Tax Collection**



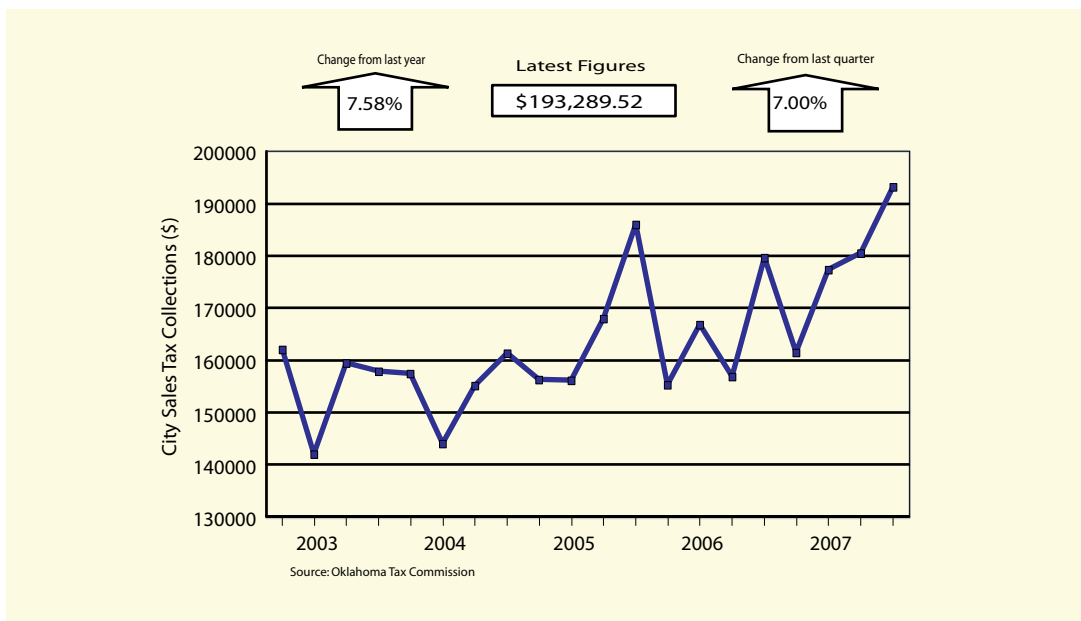
Chickasha city sales tax collections fell 0.76% between 2nd Qtr 2007 and 3rd Qtr 2007.

*Chart 6:* Clinton City Sales Tax Collection



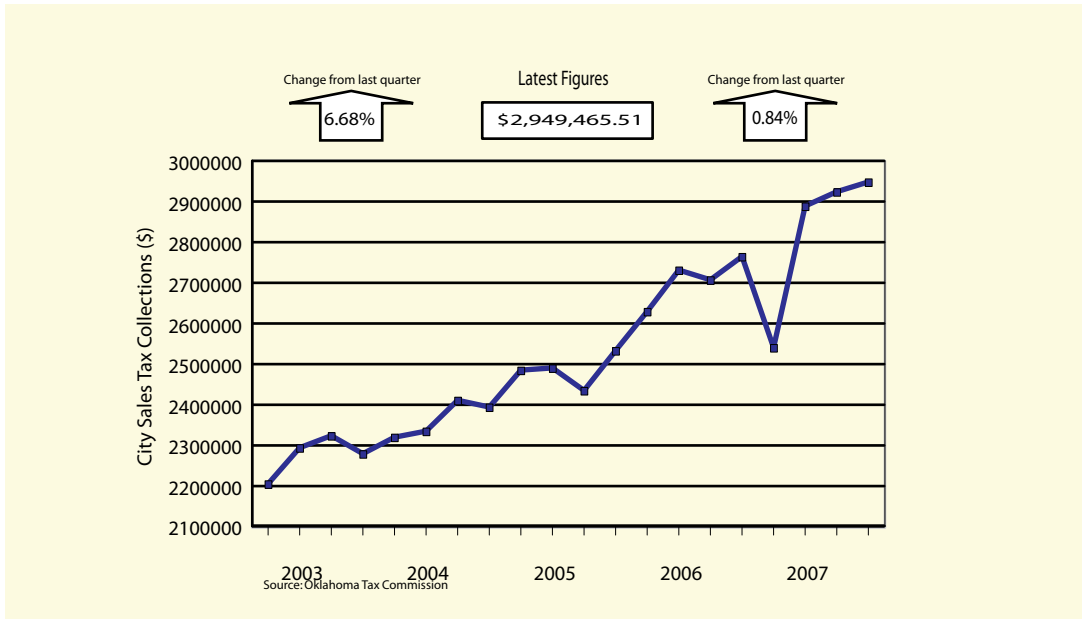
Clinton city sales tax collections are up 4.62% from the previous quarter with city sales tax collections of \$1,218,210.19.

*Chart 7:* Cordell City Sales Tax Collection



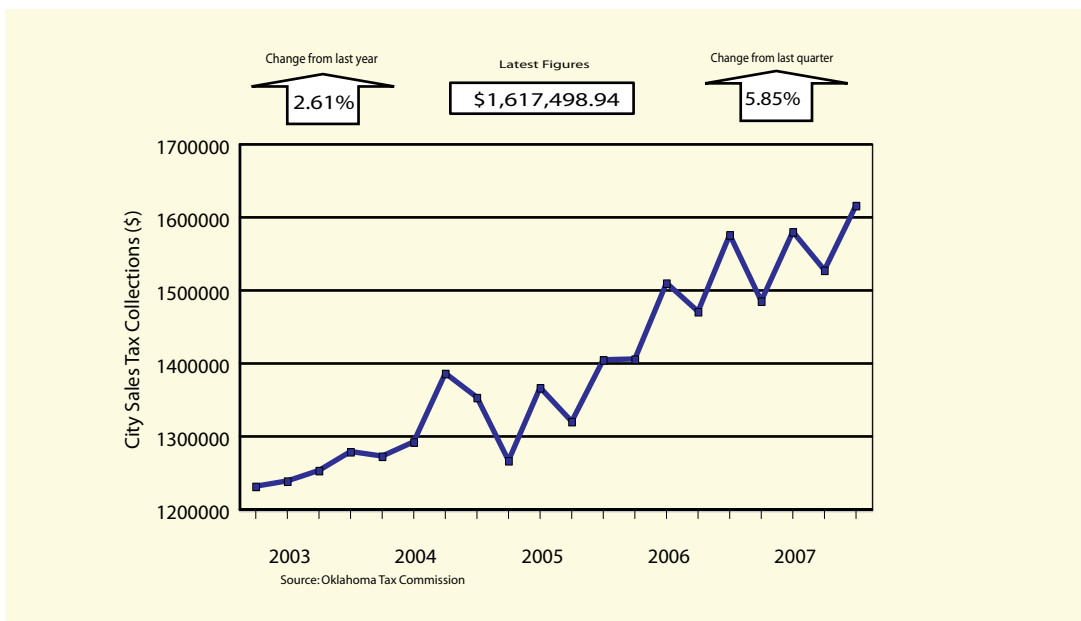
City sales tax collections for Cordell rose 7.00% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 8: Duncan City Sales Tax Collection**



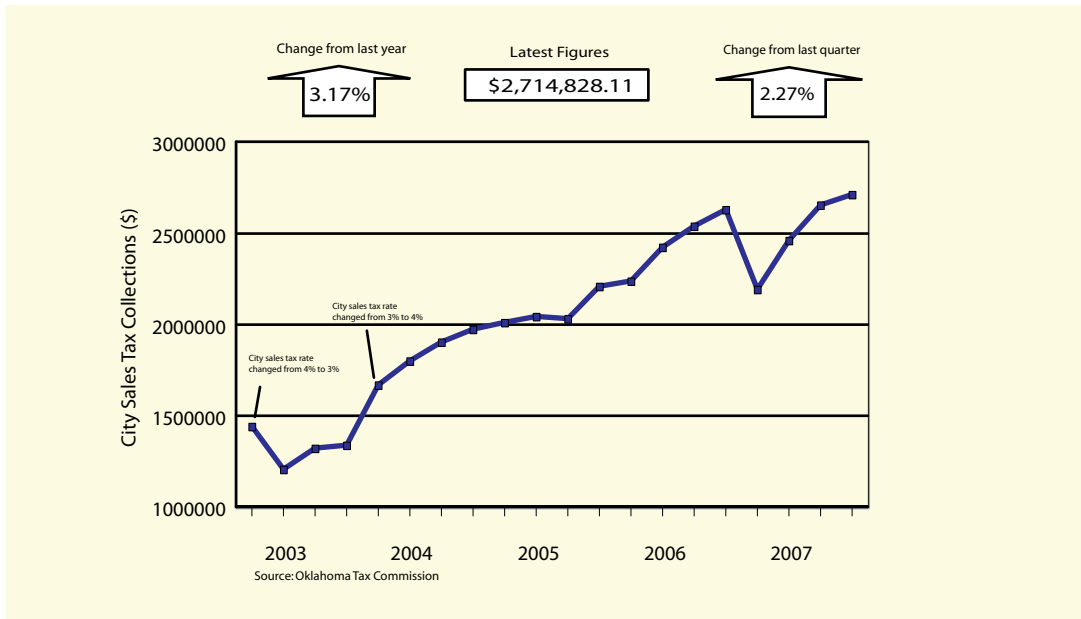
Duncan city sales tax collections are up 0.84% from the previous quarter for a total city sales tax collection of \$2,949,465.51.

**Chart 9: El Reno City Sales Tax Collection**



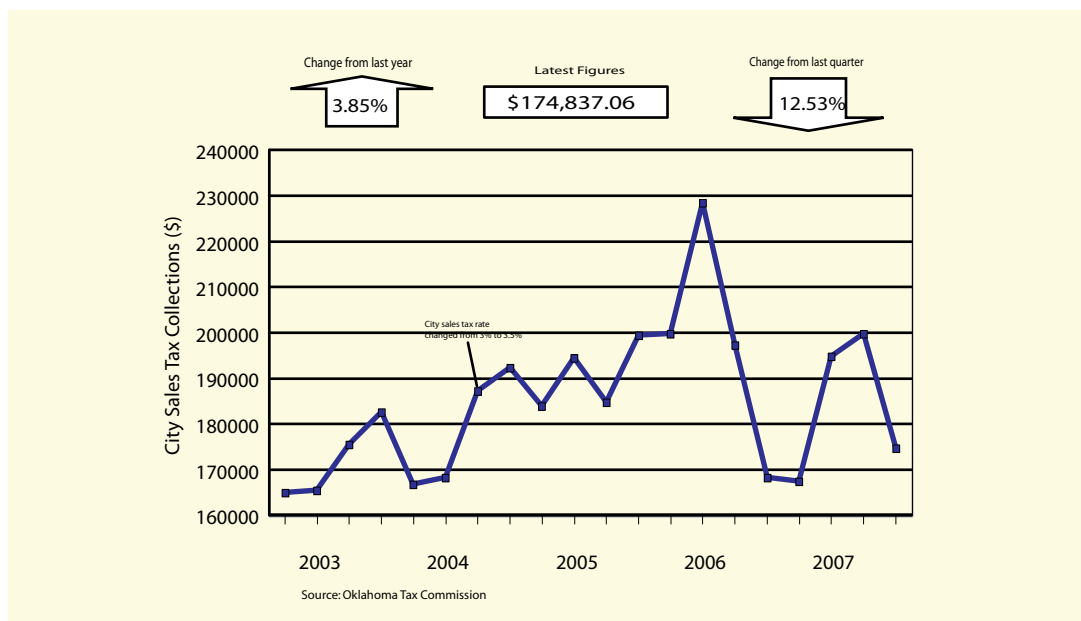
El Reno city sales tax collections are up 5.85% from the previous quarter with city sales tax collections of \$1,617,498.94.

*Chart 10: Elk City's City Sales Tax Collection*



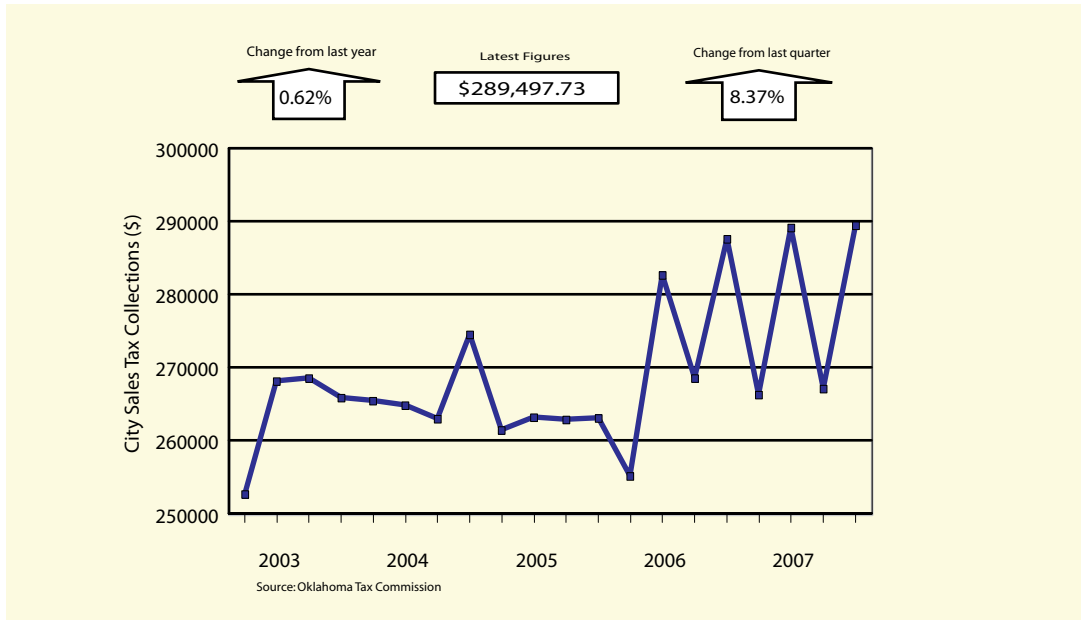

*Chart 11: Frederick City Sales Tax Collection*



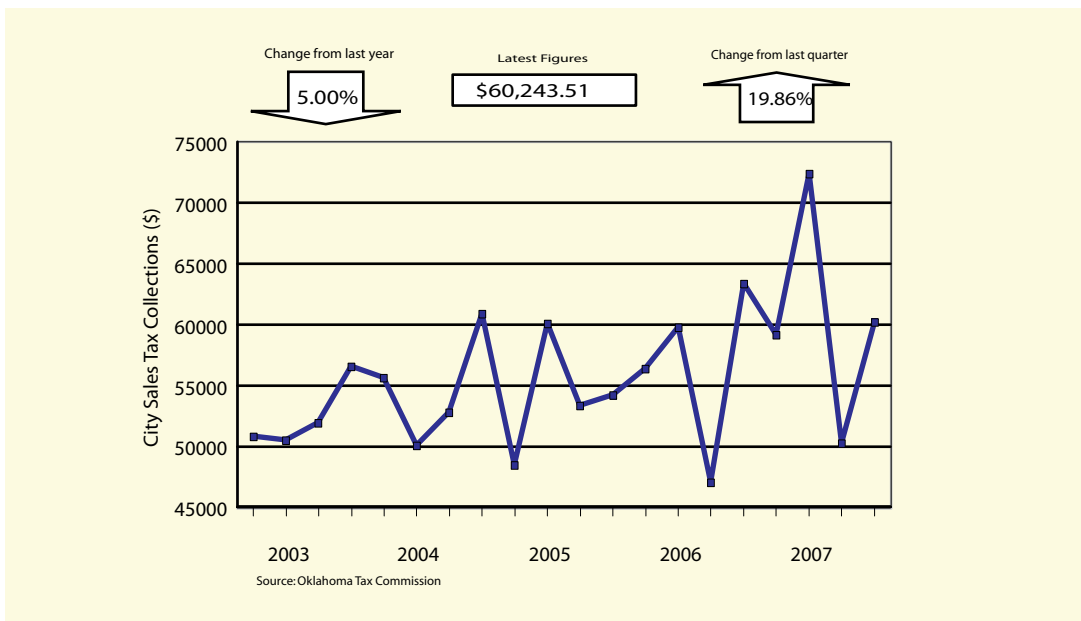

**Chart 12:** Hobart City Sales Tax Collection



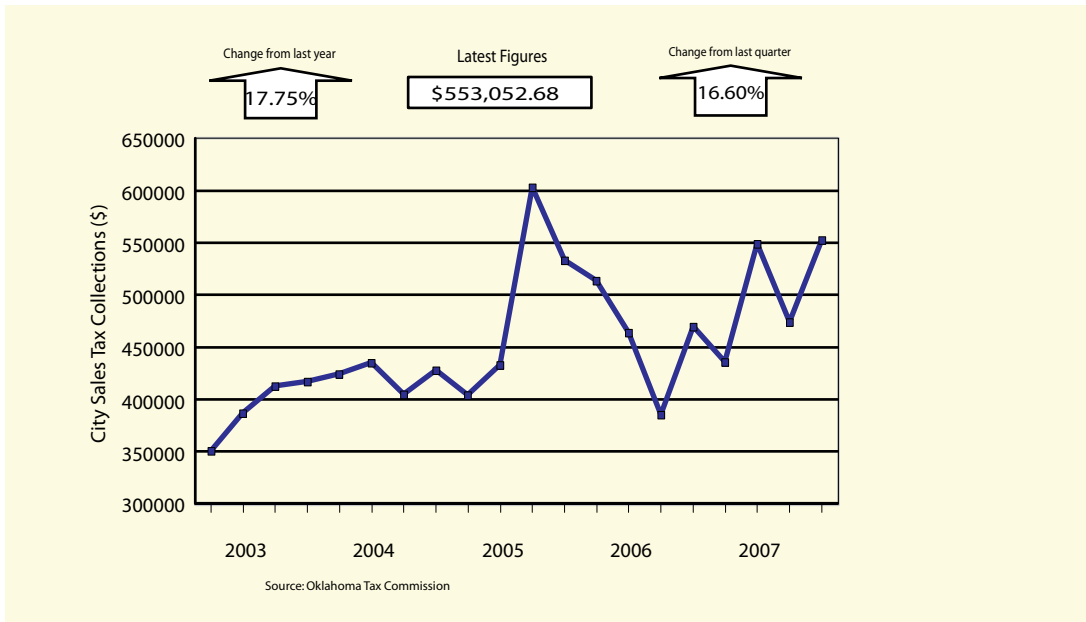
Hobart city sales tax collections rose 8.37% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 13:** Hollis City Sales Tax Collection



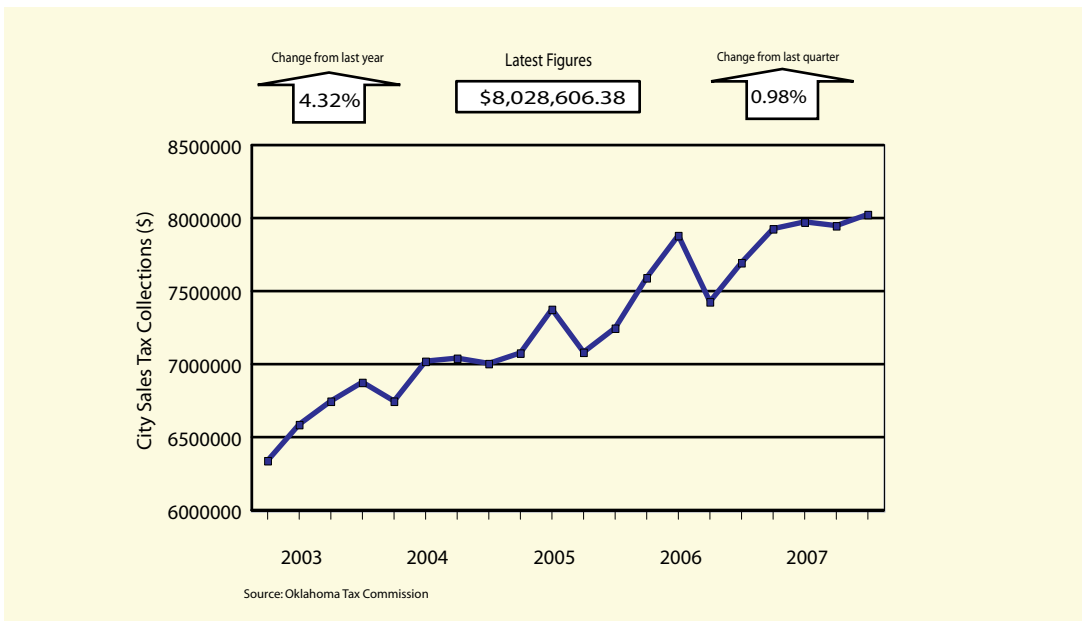
Hollis city sales tax collections are up 19.86% on the quarter for a total city sales tax collection of \$60,243.51.

*Chart 14:* Kingfisher City Sales Tax Collection



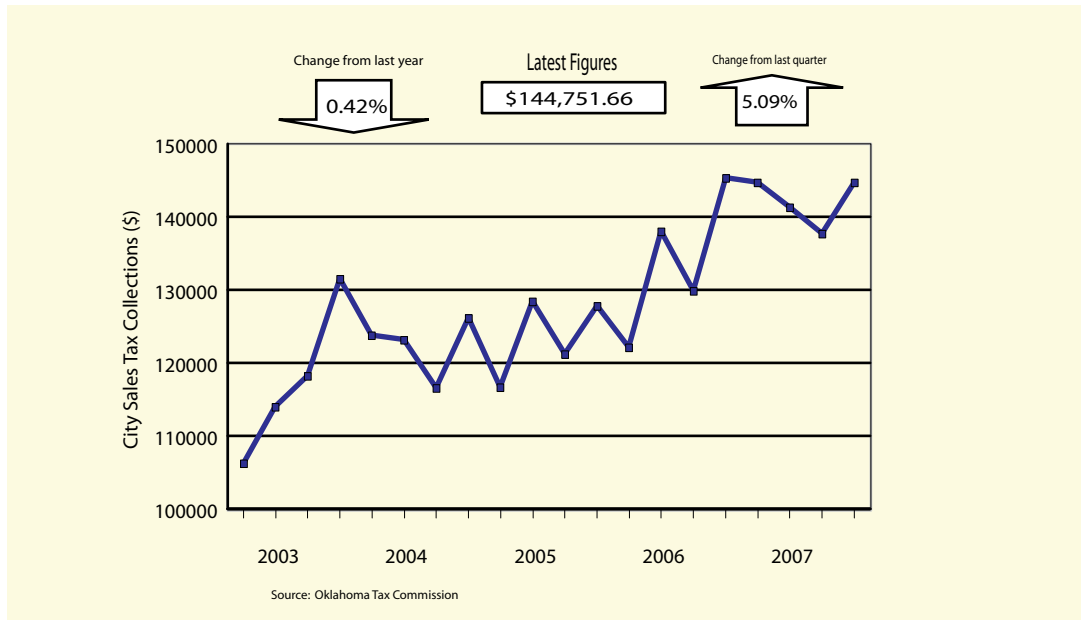
Kingfisher city sales tax collections rose 16.60% between 2nd Qtr 2007 and 3rd Qtr 2007.

*Chart 15:* Lawton City Sales Tax Collection



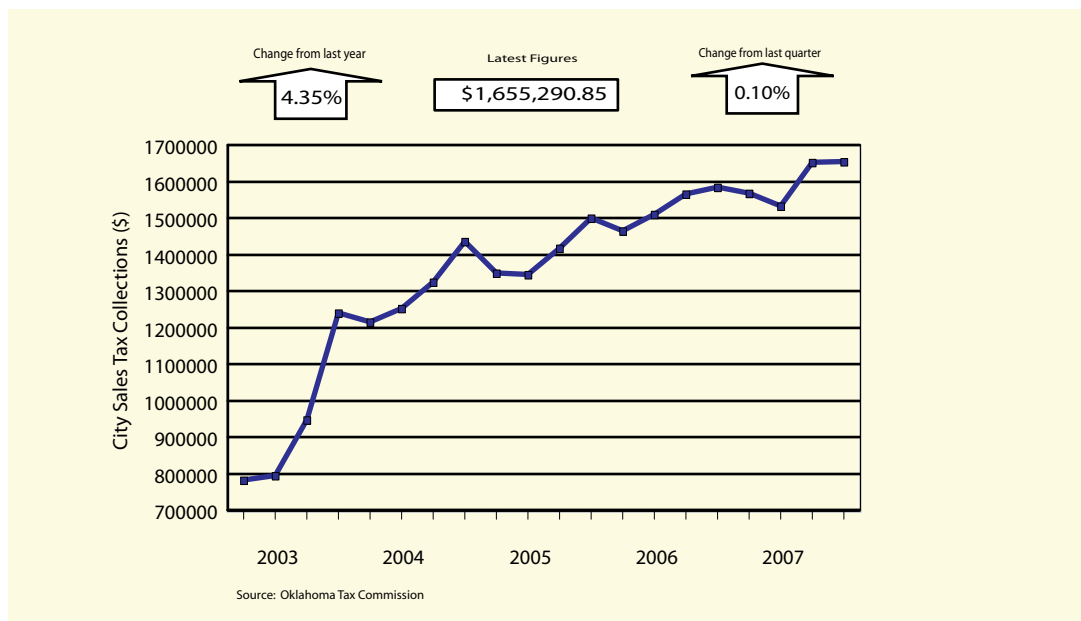
Lawton city sales tax collections are up 0.98% from the previous quarter with total city sales tax collections of \$8,028,606.38.

**Chart 16: Mangum City Sales Tax Collection**



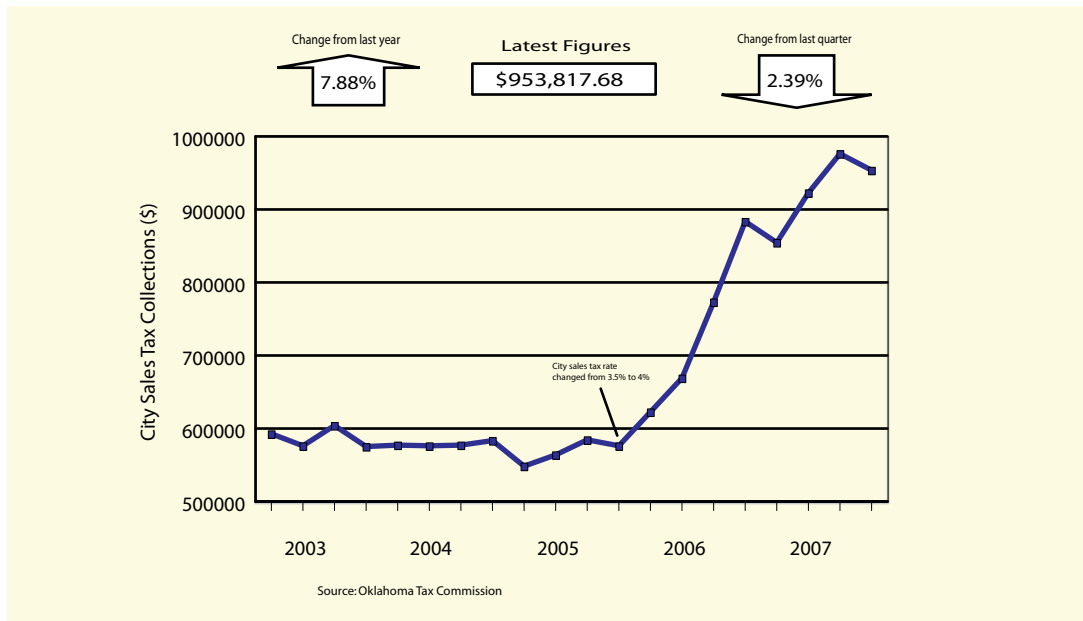
City sales tax collections for Mangum rose 5.09% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 17: Mustang City Sales Tax Collection**



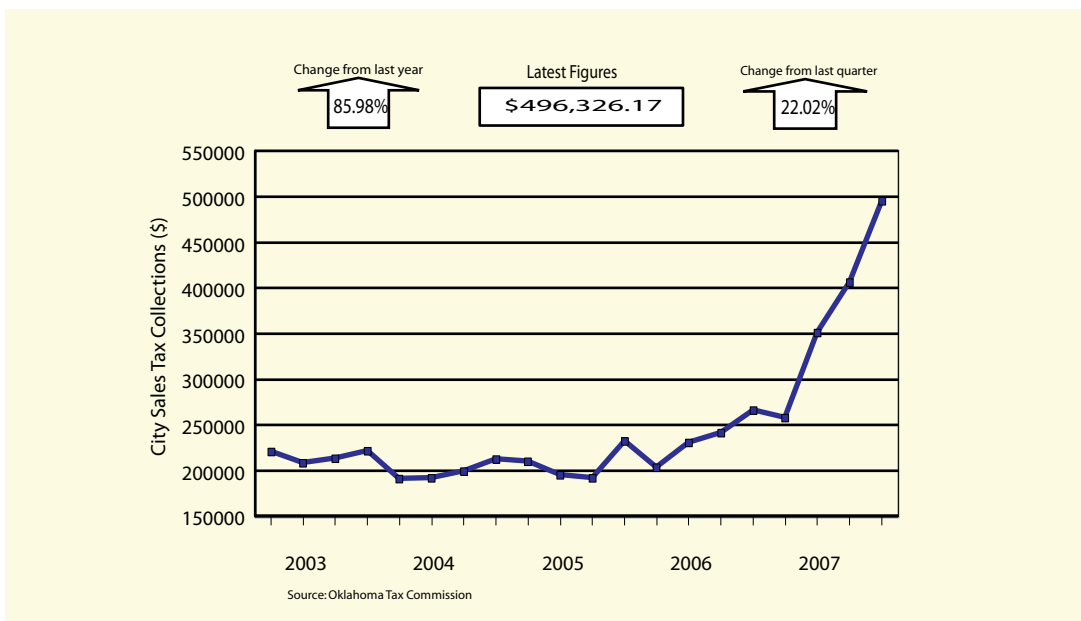
Mustang city sales tax collections are up 0.10% on the quarter for total city sales tax collections of \$1,655,290.85.

*Chart 18: Purcell City Sales Tax Collection*



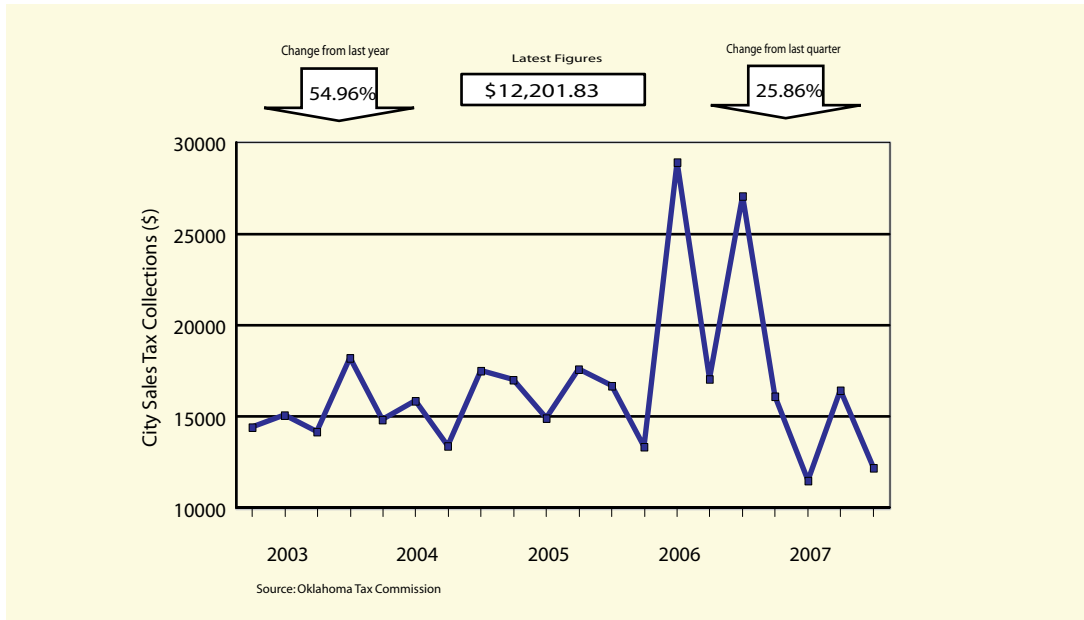

*Chart 19: Sayre City Sales Tax Collection*



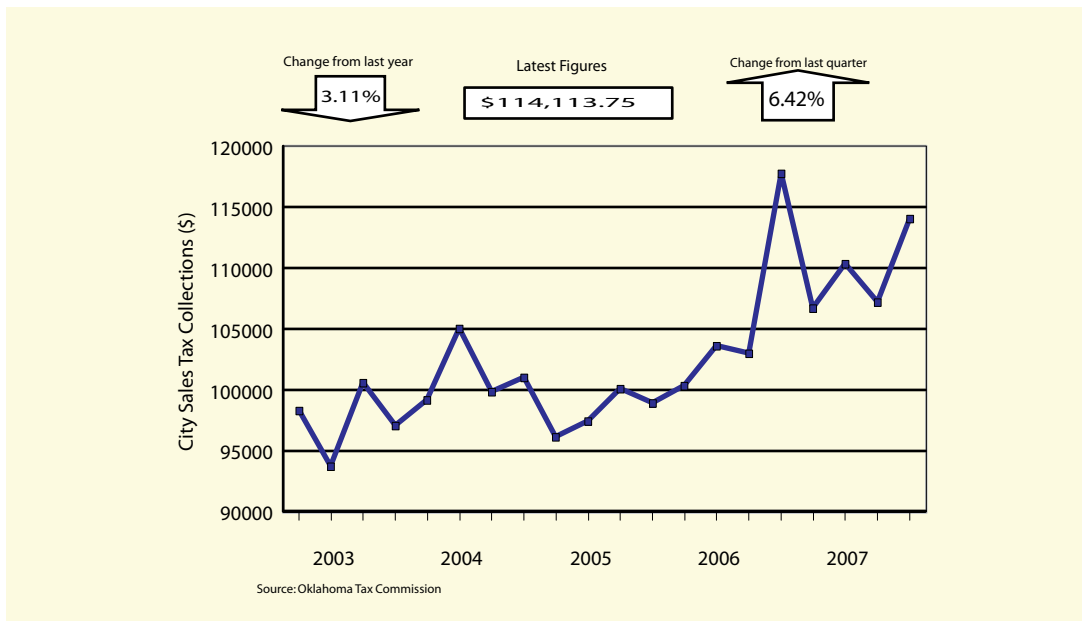
City sales tax collections for Sayre rose 22.02% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 20: Taloga City Sales Tax Collection**



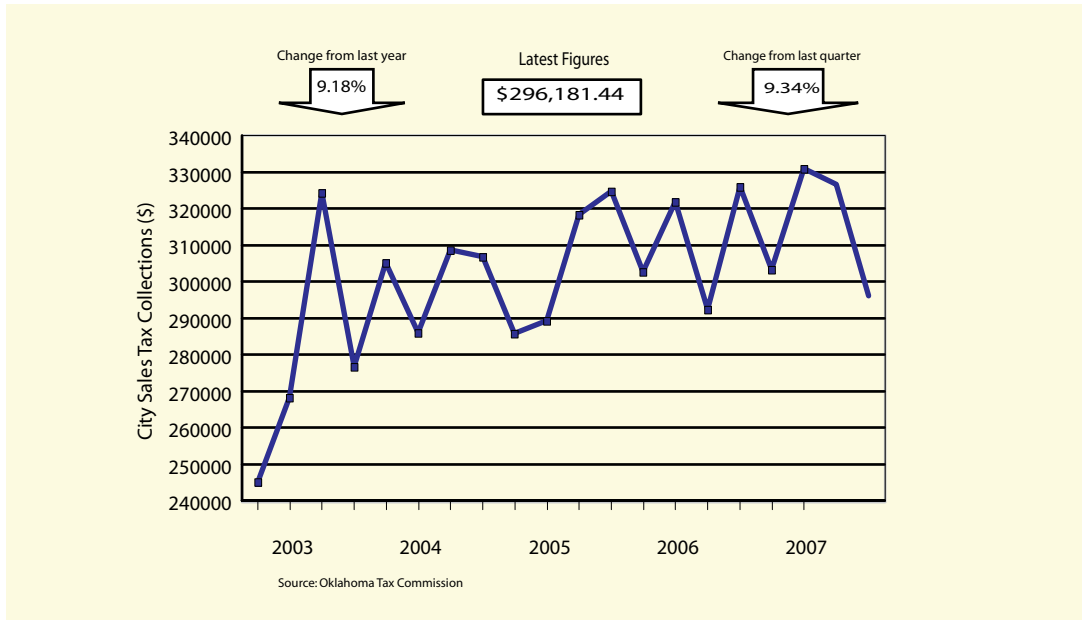
Taloga city sales tax collections are down 25.86% on the quarter for total city sales tax collections of \$12,201.83.

**Chart 21: Walters City Sales Tax Collection**



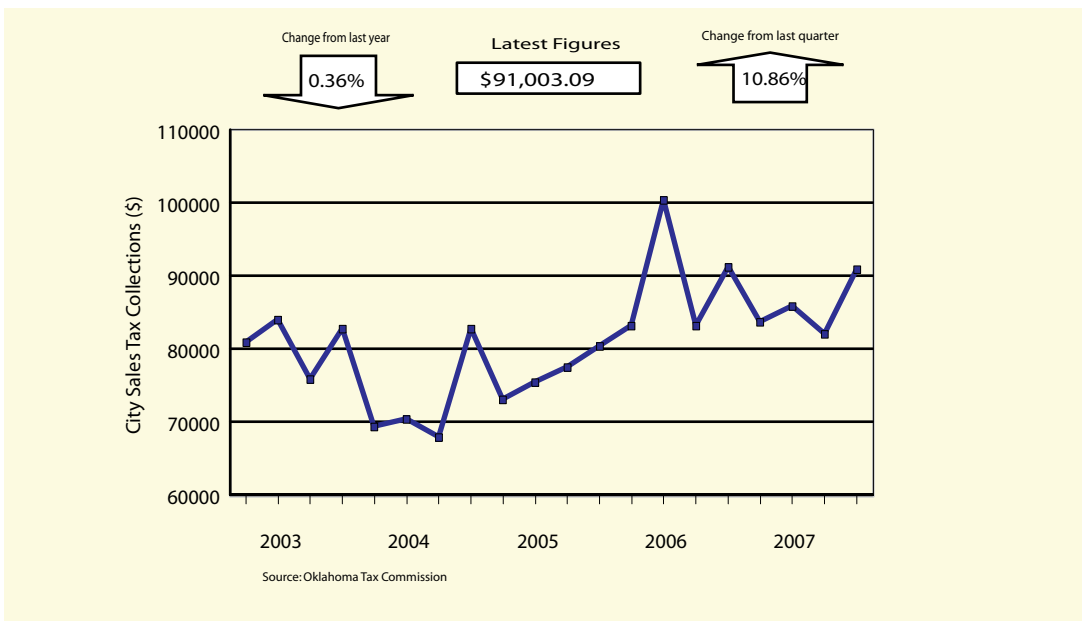
Walters city sales tax collections rose 6.42% between 2nd Qtr 2007 and 3rd Qtr 2007.

**Chart 22: Watonga City Sales Tax Collection**



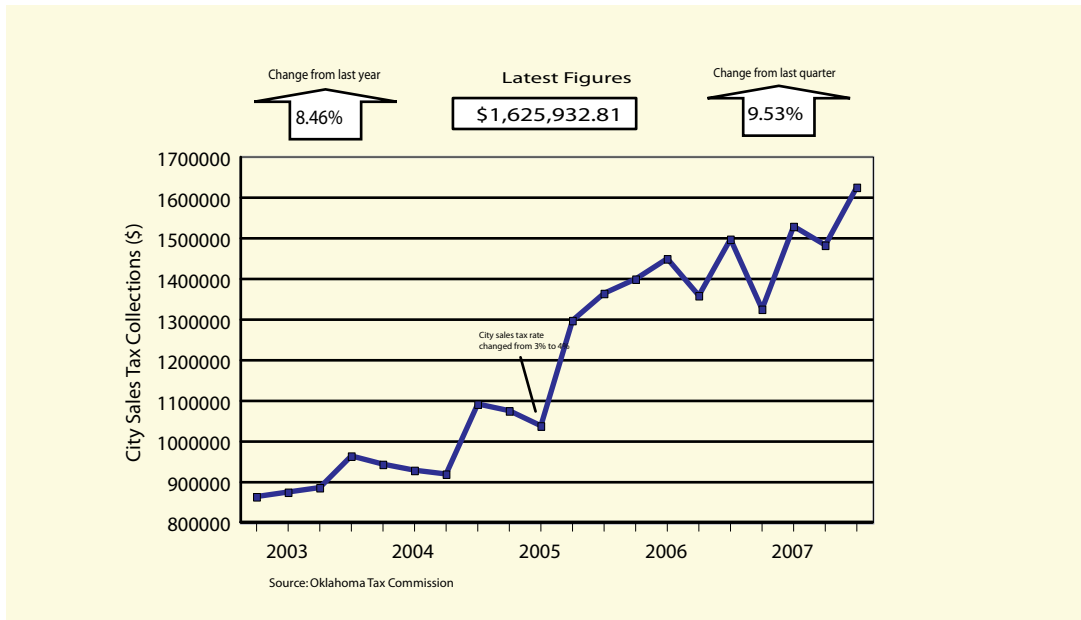
Watonga city sales tax collections are down 9.34% from the previous quarter for total city sales tax collections of \$296,181.44.

**Chart 23: Waurika City Sales Tax Collection**



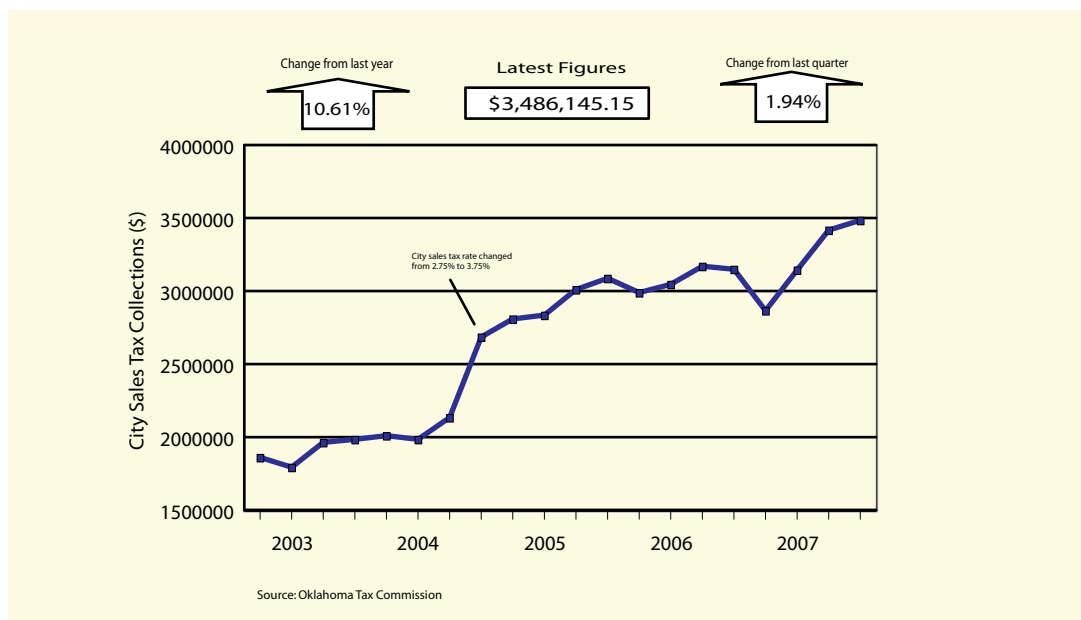
Waurika city sales tax collections rose 10.86% between 2nd Qtr 2007 and 3rd Qtr 2007
