**ACT RESIDUAL**

**Sayre Campus**

1. Effective November 1, 2011: You are encouraged to take the National ACT. However, based on policy by the Oklahoma State Regents for Higher Education, if you are unable to take the National ACT on scheduled dates, the ACT Residual test can be taken. Since the same ACT Residual Exam is given for an entire year between November 1 and October 31, if you take the ACT Residual more than once at SWOSU during this period, only the scores from the first time will count for Admission and Scholarships. All National ACT test scores count for Admission and Scholarships.
2. **ONLY** students who plan to attend Southwestern may test. Test scores **cannot** be transferred to another institution. No Student Reports or High School Reports are generated nor will any be generated to report scores to ANY other college or scholarship agency.
3. Test scores will be transmitted to the Registrar/Admissions office following each test administration. ACT Residual scores will be made part of your record at SWOSU once application has been made to this university.
4. Pre-registration at the Sayre Campus Assessment Center is required, as seating is limited.
5. Payment of \$40 is to be made at the Sayre Campus Business Office in the Administration Building prior to testing.
6. For admission to the test, students **MUST** present:
  - A. their photo ID (driver's license), and
  - B. their receipt from the Business Office
7. Examinees will be informed of the testing location at the time they pre-register for exam. (Typically exams will be administered in the Alexander Building on the Sayre Campus)
8. All testing begins promptly at **8:30 a.m.** and is completed at approximately 1:00 p.m.

**LATE ARRIVALS WILL NOT BE ADMITTED.**

9. Testing dates are as follows:

November 17, 2011	February 16, 2012	June 7, 2012
December 1, 2011	March 8, 2012	July 12, 2012
January 5, 2012	April 5, 2012	August 2, 2012
February 2, 2012	May 17, 2012	August 9, 2012

**ACT requires a 60-day waiting period between residual examinations.**

**Most calculators are now permitted for use on all ACT examinations.**

Unacceptable calculator models are: Casio CFX-9970G, Casio Algebra fx 2.0, ClassPad 300  
Texas Instruments TI-89 and TI-92, and Hewlett Packard HP 40G and HP 49G.
